1 INTRODUCTION

The ISO 9000 series of International Standards have gained widespread adoption since their introduction in 1987. Major markets and customers will require Digital to meet these standards. The continuously increasing importance customers attach to quality matters exposes Digital to significant loss of revenue should we fail to comply.

2 POLICY

- a. All named sites and organizations must establish and maintain a formal quality assurance system.
- b. The quality assurance system of all named sites and organizations must meet the particular ISO 9000 series standard specified.
- c. Each named site or organization will achieve and maintain registration to the specified ISO 9000 series standard through assessment by an approved external agency. (See Table 1.)
- d. The Corporate Quality Office will perform the following functions:
 - Determine which organizations and sites (by name) are subject to this standard and which ISO 9000 series standard shall apply. (See A-GL-ELMF732-00 *Applicability of Quality Assurance System Requirements*.)
 - Determine for each named site or organization, which external agency will provide assessment and registration.
 - Establish requirements for named sites and organizations to report registration status and assessment activities.

NOTE

The Digital standard equivalents to the ISO 9000 series of standards are identical in content, but the format may differ to permit electronic transmission.

NOTE

All Digital organizations should operate effective quality assurance programs. It is suggested that reference be made to DEC STD 017 series (Table 1) for guidance on the requirements for any quality assurance program. Selected sites and organizations are required to obtain formal registration of their quality assurance programs. Other sites or organizations not named in ELMF 732 are encouraged to operate quality assurance programs that conform to the requirements of DEC STD 017-1, -2, and -3 though they are not required to do so by this standard. Contact with the Corporate Quality Office is advised.
